Here is some interesting information. For the last 37 years, PNC bank has put together a list they call the "Christmas Price Index." They figure out how much it would cost for



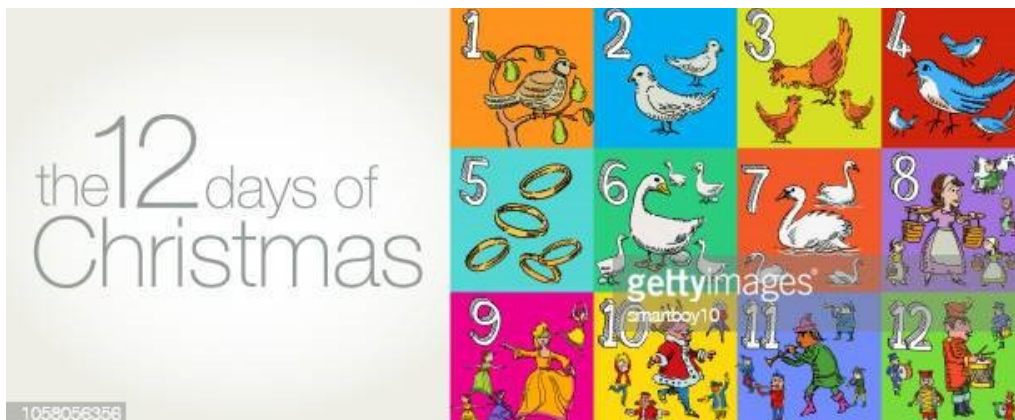

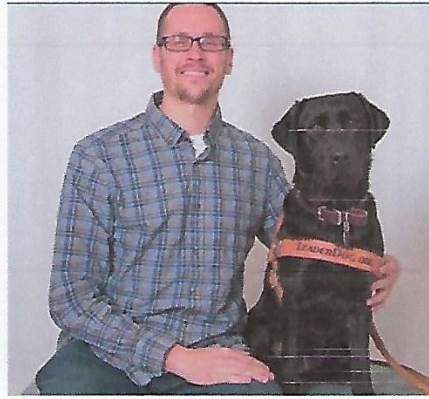
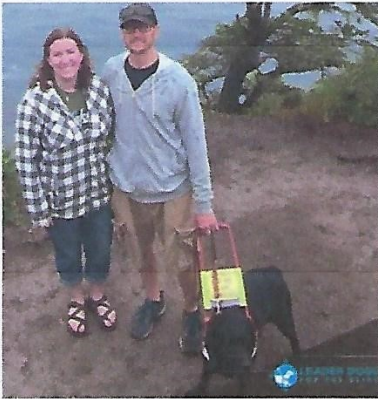

Leader Dog Client Andrew “Andy” Stone earned an MBA from ITT Technical Institute in Michigan and works for The Boeing Company in Washington. Together with his wife (above left), Andy currently has one retired Leader Dog, two cats and a horse. He received his first guide dog, Leader Dog Ingrid, in 2008 and his second dog, Leader Dog Rayna, in 2016 (above right).

“Thinking back to when I got my first Leader Dog, Ingrid, I was at a really different place in my life. It wasn’t the best of places; it was when my vision started to get bad and I wasn’t handling it very well. I wanted to have a companion with me all the time and getting Ingrid really made a huge difference in my mental state at that time and it made me more independent to get out more. I didn’t get her to be outdoors more because then I was relying on friends and family to help me out with stuff.

I’ve always had Retinitis Pigmentosa, but we didn’t really know about it until I was in my late teens/early 20’s. My whole life I’ve had difficulty seeing in the dark and now I have a little central vision that is still fairly good when I’m super close to something. In order to tie flies onto the line when I’m fishing, I have glasses with magnifiers in them. There were many times when I had my first Leader Dog, Ingrid, that she and I would go fishing on our own.”

Andy’s journey is like many of the clients Lions help us support. Regaining his independence and confidence re-opened opportunities for him.

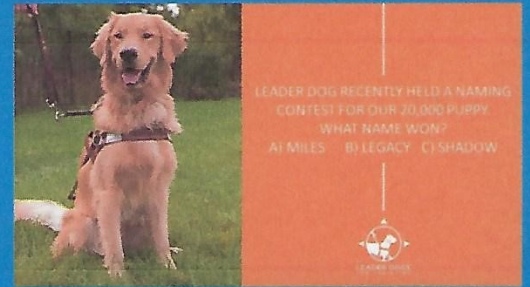

Dear Michigan Lion:

On June 28, 2018, Governor Rick Snyder signed Public Act 255, creating a Lions of Michigan Foundation Fund within the Michigan Department of Treasury to assist our foundation in collecting donations to help improve the quality of life of people in our state with unmet needs. Public Act 255 of 2018 added our Lions of Michigan Foundation to the list of only nine Michigan charities eligible to receive donations directly from Michigan tax payers when they file their annual state income tax return.

As each qualified charity is required to collect \$50,000 in donations annually through this special program to guarantee eligibility for the future, we are asking for any help that you can provide to ensure that we remain eligible. Just a donation of \$5 to \$10 to our foundation from each Michigan Lions member or a family member or friend on the Michigan Voluntary Contribution Schedule (MI Form 4642) would ensure that we cannot be removed from the list of qualified charities.

Since 1984, our Lions of Michigan Foundation has operated programs that address serious human needs in our state. By working in partnership with our Michigan Lions Clubs and other community service organizations and charities, we provide disadvantaged Michigan families with access to affordable eye care, hearing aids and services aimed at helping people succeed academically and socially, gain and retain employment, maintain independence and prosper in life. We support our member Lions Clubs and their communities to help make them stronger and more viable.

Our foundation provides funding for equipment, supplies and program expenses for Project KidSight and the resources necessary for our Michigan Lions to help children suffering from vision loss. Through our Emergency Individual Assistance Program, our foundation helps military families and veterans who have emergency needs, and we help people who suffer from severe vision and hearing disorders that can only be corrected through surgical intervention or costly medical procedures. Through our Lions Affordable Hearing Aid Program, our foundation helps low-income people who suffer from hearing loss maintain self-sufficiency. And, through our Emergency Disaster Relief Program, we help families affected by natural disasters, including severe storms, flooding, fires and tornados.

We greatly appreciate any support that you and your family members and friends can provide to assist us in raising the \$50,000 required to remain as one of the charities eligible to receive donations through Michigan income tax return filings. With your help, we can continue to play a significant role in solving the social, economic and health care issues facing our state.

Instructions for Form 4642, *Voluntary Contributions Schedule*

Michigan taxpayers can contribute \$5, \$10, or more to any of the following funds on the *Voluntary Contributions Schedule* (Form 4642). **Contributions to these funds will increase your tax liability or reduce your refund.**

American Red Cross Michigan Fund

The American Red Cross is always there for you and your community, helping to alleviate suffering caused by disasters big and small. The Red Cross shelters, and provides emotional support to Michigan residents and beyond; supplies about 40 percent of the nation's blood; teaches skills that save lives; provides international humanitarian aid; and supports military members and their families. By mobilizing the power of volunteers and the generosity of donors, the Red Cross responds to more than 60,000 disasters annually. In Michigan, last year more than 6,000 volunteers logged more than 200,000 hours assisting others. On average 91 cents of every dollar the Red Cross spends is invested in humanitarian services.

Animal Welfare Fund

The outside world can be a harsh, scary place for homeless pets. And throughout Michigan, small towns and big cities alike struggle to find the resources they need to provide medical care to the animals they rescue. Through the Animal Welfare Fund, the Michigan Department of Agriculture and Rural Development (MDARD) offers grants to Michigan's registered animal shelters to help support spaying and neutering programs for shelter dogs and cats up for adoption. Grants also help support many anti-cruelty and proper care programs around the state. Shelters also use grant monies from your generous donations to help care for animals that are seized as part of animal cruelty cases.

Children's Trust Fund - Prevent Child Abuse Michigan

The Children's Trust Fund (CTF) supports services throughout Michigan to prevent child abuse and neglect. CTF funds home visitation services; respite care; services for families with incarcerated family members; and parenting education and support. CTF supports a statewide network of local Child Abuse and Neglect Prevention Councils. Examples of local Council work are teaching professionals about mandated reporting; teaching parents and caregivers about infant head trauma prevention and infant safe sleep practices; and establishing baby pantries to provide diapers, formula, and clothing. In the coming year, CTF and its local Councils will lead statewide efforts to build local responses to the opioid crisis.

Fostering Futures Scholarship Trust Fund

Fostering Futures Scholarship provides scholarships to young adults who have experienced foster care to help them achieve a college education. Approximately 13,500 students are in the Michigan foster care system and many students do not have family support after they age out of the system. Nationally, about 75 percent of students express a desire to attend college, less than 10 percent enroll in college and less than three percent graduate college. Scholarships are awarded via an application process and paid directly to the students' college or university to assist with tuition, fees, room, board, books and supplies. Kiwanis Fund

Kids need Kiwanis! Military Family Relief Fund

The Military Family Relief Fund provides grants to qualifying families of military members in either the Michigan National Guard or Reserves who are called to active duty as a result of the national response to the September 11, 2001 terrorist attacks.

DISTRICT 11 A2 DISTINGUISHED SERVICE AWARD

PURPOSE: To recognize a District 11 A2 Lion, Lioness, or Leo for sustained, outstanding commitment and dedicated service as a Lion, Lioness or Leo to the Community and District.

CRITERIA:

- Service must include club & district level participation. MD & LCI level participation is NOT a requirement although can be a plus. (NOTE: This is intended as a District award for service at the District & Club level in this District.)
- Must have served in a leadership role at the Club and District level.
- Demonstrated service in support of one or more of the established District projects & programs.
- Demonstrated service directly involving voluntary service to the Community.
- Must currently be a District 11 A2 Lion, Lioness or Leo in good standing as a full member with a minimum of seven years membership in the District at the time of the District Convention where this award is to be presented.
- Nominee may NOT have been previous recipient of the Harold Pocklington Service Award. Nominee may NOT be currently serving as an International Director, District Governor or as a Vice District Governor.
- Nominations must be submitted in writing to the Immediate Past District Governor not later than February 1, 2021 in proper format.

SELECTION PROCESS:

- The Honorary Committee, chaired by the IPDG, shall consist of those PDG's who are active members of a District 11A2 Lions Club. The District Governor shall be a part of voting process but may not make a nomination.
- Only one nomination by each member of the Honorary Committee, consisting of Past District Governors, may be submitted during a Lion's year.

- Nominations shall be submitted, in writing, or by email to the most recent IPDG. Following the selection, the IPDG shall be responsible to obtain the plaque and medallion. IPDG will also be responsible for having them engraved and shall present the award at the Annual District Convention Banquet. If the current IPDG is unable to do the presentation the next previous IPDG will do the presentation.
- Information collected along with the medallions and engraving for plaques shall be shared with the next IPDG following the presentation of the Distinguished Service Award and the last meeting of the Honorary committee.

In order to secure complete nomination information, a PDG may need to contact the person being nominated. This information should remain confidential within the Honorary Committee.

In the event that a PDG is nominated for the Distinguished Service Award, the Chairperson of the Honorary Committee (or other designated chair if the IPDG is a nominee), upon receipt of the completed nomination form, shall notify the nominated PDG. Thereafter, the nominated PDG shall not participate in the selection process during the Lion's year of the nomination.

VOTING PROCESS:

- IPDG will call for a meeting of the Honorary Committee (consisting of active PDG's who have served for District 11A2) no less than 30 days prior to Annual District Convention. A quorum of the selection committee shall be no less than one third of the eligible members. If there is not a quorum or if no candidate receives the stated amount of votes, the award shall not be given in that year.
- Voting shall be by written ballot or via telephone conference call (if necessary). The recipient must receive one more than 50% of the ballots cast. If no nominee receives 1 more than 50% of the ballots cast, then the committee will take the top two (2) nominations and revote. Winner will be determined by who receives 50% plus one vote.
- No proxy votes will be allowed and a Past Pocklington Award recipient will count the votes as directed by the IPDG.
- The Honorary Committee will be asked to keep the winning nomination a secret until Annual District Convention.
